SECTION I

1. The name of this group will be:

THE MISSISSIPPI STATE ELKS ASSOCIATION
HALL OF FAME

2. The Mississippi State Elks Association Hall of Fame will be administered by a HALL OF FAME COMMITTEE consisting of a CHAIRMAN and FOUR (4) COMMITTEE MEMBERS. Said committee to be appointed annually by the President, Mississippi State Elks Association.

SECTION II

1. The purpose of the MISSISSIPPI STATE ELKS ASSOCIATION HALL OF FAME is to:

- a. Give full and permanent recognition to those individual members of the various subordinate lodges affiliated with the Mississippi State Elks Association who have distinguished themselves in an outstanding manner in the furtherance of Elkdom in their hometown, the State of Mississippi, and/or nationally.
- b. To provide those individuals who are selected for installation in the Mississippi State Elks Association Hall of Fame with a suitable certificate and engraved plaque in testimony of their selection.
- c. To originate and maintain a permanent record reflecting full information pertaining to those individuals installed as members of the MISSISSIPPI STATE ELKS ASSOCIATION HALL OF FAME.

SECTION III

1. To be eligible for selection and installation in the Mississippi State Elks Association Hall of Fame, the candidate must be a member in good standing of a subordinate lodge located in the State of Mississippi and affiliated with the Mississippi State Elks Anns.
2. Special consideration may be given to those individuals who are members in good standing of Elks Lodges located outside the State of Mississippi and NOT affiliated with the Mississippi State Elks Assn who have distinguished themselves within the State of Mississippi while working in the best interests of Elkdom

SECTION IV

1. Proposals for membership in the Mississippi State Elks Assn Hall of Fame may be made as listed below:

- a. A subordinate lodge may nominate a member in good standing of its lodge, providing such information required on the Proposal Form, and submitting it to the Hall of Fame Committee. Such proposition should be signed by the Exalted Ruler, Secretary, or other suitable officer of the Lodge.

- b. Any member in good standing in a subordinate lodge may propose or nominate any other member in good standing within his lodge or any other lodge affiliated with the Mississippi State Elks Assn provided full and complete information is provided on the Proposal Form concerning the candidate. Such proposal should be signed by the member making the proposal and submitted to the Hall of Fame Committee.

2. Proposals for membership in the Mississippi State Elks Assn Hall of Fame of individuals who are members of an Elks Lodge located outside the State of Mississippi may be made the same as outlined in Paragraph 1 above. It will be the responsibility of the lodge or individual making the proposal to obtain the information concerning the out-of-state candidate and provide such information as required on the Proposal Form to the Hall of Fame Committee.

SECTION V

1. The Hall of Fame Committee, upon receiving a proposal for membership will:

- a. Thoroughly investigate the information contained in the proposal for accuracy and authenticity.
- b. Consider and compare with other proposals to determine if the candidate is worthy to be admitted to membership in the Hall of Fame.
- c. If the candidate is considered worthy, the Committee Chairman will announce the committee findings and recommendations to the assembled association.

2. The Mississippi State Elks Association, after hearing and considering the recommendations of the Hall of Fame Committee, may vote to accept or reject the proposed candidate.
